# PERSONNEL QUALIFICATIONS.

(a) It shall be the responsibility of the research facility to ensure that all scientists, research technicians, animal technicians, and other personnel involved in animal care, treatment, and use are qualified to perform their duties. This responsibility shall be fulfilled in part through the provision of training and instruction to those personnel.

\*\*\*Death of a macaque (PWc2) occurred due to equipment that was incorrectly assembled. Recent construction in the area and new employees are contributing factors to this incident. All personnel handling animals must be properly trained and familiar with equipment involved in conducting a study. Appropriate training and instruction must be made available prior to conducting animal activity. To be corrected from this day forward (11 July 2006).

# ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE.

- (b) Each research facility shall establish and maintain programs of adequate veterinary care that include:
- (1) The availability of appropriate facilities, personnel, equipment, and services to comply with the provisions of this subchapter

\*\*\*Poorly labeled equipment contributed to the anesthetic death of animal PWc2. Laboratory equipment utilized in animal studies must be properly labeled and maintained. New methods of labeling pressurized gas lines have been implemented. To be corrected from this day forward (11 July 2006).
