

- Vervet #1996-022, Public Records Request of Marcelo E. Nasif: We have confirmed that there are no responsive documents in our current or archived records for this subject. This non-human primate was housed at a facility other than UCLA.
- Vervet #1995-101 Public Records Request of Geraldine Teichelman: We have confirmed that there are no responsive documents in our current or archived records for this subject. This non-human primate was housed at a facility other than UCLA.
- Primate B15A, Public Records Request of Ngiare Elliot. The records regarding this subject were purged in accordance with UCLA's records retention policy and schedule, and were not available

UCLA's records retention policy and schedule, and were not available at the time of the request, August 8, 2005. There are no responsive documents in response to this request. This non-human primate is deceased.



Requests were made by numerous PFP supporters who contacted UCLA but were told the primate on their Tag did not exist etc. However, these were bald-faced lies UCLA told the public to avoid providing the dirty details of what was happening inside the UCLA labs.
